Introduction

This policy statement sets out Salisbury Sixth Form's (the Academy) arrangements for managing the access of providers to the Academy for the purpose of giving them information about the provider's education or training offer. This complies with the Academy's legal obligations under Section 42B of the Education Act 1997.

The Academy is committed to safeguarding and promoting the welfare of its students and expects all staff, partners, visitors and volunteers to share this commitment. Our safeguarding policy outlines the Academy's procedure for checking the identity and suitability of visitors. Education and training providers will be expected to adhere to this policy.

At S6C careers education is viewed as critical to a young person's success in raising their aspirations and ensuring they have explored the range of pathways for progression that are available to them.

Student entitlement

All students in years 12 and 13 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses.

These provider encounters will be scheduled during the main Academy hours and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- explain what career routes those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- answer questions from pupils.

Meaningful Provider Encounters

One encounter is defined as one meeting/session between pupils and one provider. We are committed to providing meaningful encounters to all pupils.

Meaningful online engagement is also an option, and we are open to providers that are able to provide live online engagement with our pupils.

Destinations of our pupils

Our careers programme supports progression to university, apprenticeships and employment and on average around 65% of students progress to university and around 30% of students progress to apprenticeships and employment.

Our students progress to a variety of universities across the UK including some of our local providers such as The University of Winchester, Bournemouth University and the University of Southampton as well as other Russell group universities including the University of Bristol, University of Exeter and University of Oxford.
